Brief CV

As of October 2024, Nephele Papakonstantinou is Assistant Professor of Latin Philology at the Department of Philology of the University of Athens. A graduate of the same department (2010), she completed her Master's (2011) and PhD (2017) in Classical Studies, specializing in Latin Philology, at the Sorbonne University (Université Paris Sorbonne - Paris IV), with highest honours. Through generous funding from the Alexander von Humboldt Stiftung (2021), she carried out independently and as Principal Investigator a two-year postdoctoral research project, with published deliverables, at the Institut für Klassische Philologie of the University of Würzburg, where she remains a Research Associate, funded again by the Alexander von Humboldt Stiftung (2025) for her ongoing research project on the mechanisms of the formation of medical law in Graeco-Roman antiquity and early modern Europe. She has been positively assessed by the Conseil National des Universités of France (2023) as having met all the necessary qualifications and requirements for the grade of Maître de Conférences in Section 08. She has received research fellowships from, among others, the Centro di Studi e Ricerche sui Diritti antichi (Dipartimento di Giurisprudenza) of the University of Pavia (2022), the Siebold-Collegium Institute of Advanced Studies of the University of Würzburg (2022), the Hardt Foundation (2018), the École Française de Rome (2014, 2015, 2016), the University of Athens (2011) and the Greek State Scholarships Foundation (2007). She has presented her research by invitation or after selection at 21 universities and research centres abroad in the context of international conferences and seminars, and has (co-)organized three international conferences abroad (two in Germany and one in Italy) thanks to funding from other institutions and bodies (e.g. Fritz Thyssen Stiftung, Institutio Santoriana - Fondazione Comel). She is a reviewer of articles submitted to international journals (e.g. *Lexis*, *Hormos*) and an Associate Member of the scientific group EDITTA (UR 1491) of the Sorbonne University.
